### **Emergency Burn Care Update**

*Ernest Grant, PhD, RN, FAAN, Nursing Education Clinician-Burn Outreach, NC Jaycee Burn Center, UNC Hospitals, Chapel Hill*

The burn injury is too often treated as a single organ injury with other organs, systems and structures of the body overlooked in initial care. This session is designed to provide pre hospital, emergency department and critical care providers with a working knowledge of the major components in current burn care during the emergent period (0-72 hours) post injury. The session will mainly focus on thermal injury with an emphasis of pathophysiological processes and principles related to the management of fluid resuscitation, inhalation injury, wound care, and potential complications. Participants will examine their roles as members of the interdisciplinary team
