## AHA Instructor Network Portal Announced

### Special Limited Time Offer for Training Center Coordinators

On January 27<sup>th</sup>, our National Center sent emails to all AHA Training Centers, announcing the upcoming launch of our Instructor Network. Along with the announcement, came a special offer for Training Center Coordinators. For a limited time, at no cost to you, the AHA will enter your Instructor's information into the Instructor Network system. This pre-approval process will save time because:

- you will not have to manually *enter* your instructor info
- you will not have to manually *confirm* your instructors on an individual basis, as they request access
- your instructors won't have to *wait* several days for access

## GUIDELINES UPDATE INFORMATION

### Guidelines Update Packets

These packets were mailed out the last week in January, by UPS, to all Training Center Coordinators. In these packets are (2) DVDs and (1) CD ROM that contains the information you will need for the Guidelines rollouts conducted for your Training Center Faculty and Instructors.

It has come to our attention that some TCs, upon receiving the Guidelines Update Packet (DVD's & CD's), have begun "rolling out/updating" their instructors and are using these materials in their courses.

**The materials sent to TC's are meant to be used by Regional Faculty and your Training Center Faculty to conduct your instructor updates ONLY AFTER THE RF and TCF HAVE COMPLETED AN OFFICIAL GUIDELINES UPDATE TRAINING SESSION.**

Upon completion of one of these updates, the TCF will be able to conduct the updates by coordinating their update plan with assigned Regional Faculty. If there are no TCF yet appointed or a TC was unable to have a TCF attend one of our scheduled sessions, the TC will look solely to their assigned Regional Faculty to provide the updates.

**CD ROM:** Insert into your drive. Go to my computer. Right click on the 06ECC Rollout CD, and select OPEN.

**Powerpoint Presentations:** if you are having trouble viewing the PPT, you may not have PPT 2003. A free downloadable viewer is available from Microsoft.

**COURSE CREDENTIAL CARDS**

As we go back to reprint on cards, there will be some revisions. For example, new cards will not be self-sticking, and will use the back of the cards for additional information about the course, AHA's website, etc. These "new" cards will have additional security measures, such as micro-printing and shading over the Name, Issue Date, and Recommended Renewal Date fields. In addition, there will be revisions to certain cards such as HS CPR and HS AED to reflect the combining of Adult and Child CPR skills. There will also be new cards to go with the Pedi First Aid course.

However, existing cards are not invalidated. These changes are all reprint changes. So, you can continue to use the current cards you have on hand, and order cards as you need them.

**NEW 2006 EXAMS**

Answer sheets and keys for the current ACLS and PALS written exams have been modified. The questions affected by the new science, have been blacked out, so that students will not answer these questions. Scores will be calculated on the number of remaining questions. Instructors will be able to incorporate new science into their courses by using bridge materials, along with old student materials and old exams, until the new provider materials are available.

New exams will be introduced at the same time as the release of the new provider materials. New 2006 BLS HCP exams are currently available. These new exams, and the modified answer sheets and keys for BLS, ACLS, PALS, and Heartsaver will be distributed to the appropriate discipline specific TCs and RF very soon in a communication from the Service Center.
