Vicki Hardy, D.O. Dr. Vicki Hardy recently completed a Faculty Development Fellowship at Duke/ Southern Regional Area Health Education Center June 2017. Dr. Applegate has also worked in a sexual dysfunction clinic, lectures on sexual dysfunction among medical patients, and does consulting work on the impact of surgery on sexual quality of life.

Alexandra Hill graduated from Kent State University with a B.S. in Chemistry, going on to earn her Doctor of Physical Therapy at the University of Florida and complete the Women's Health Physical Therapy Residency at Duke Health. Alexandra is a board-certified women's health clinical specialist and certified lymphedema therapist. In addition to her clinical work at Duke Health, she is a teaching assistant for the Duke University Doctor of Physical Therapy program. Alexandra has authored several peer-reviewed research publications on pelvic floor dysfunction and oncology-related concerns. She lectures locally and nationally on topics including pelvic floor dysfunction, lymphedema, physical therapy for the oncology population, and physical therapy for the obstetric patient.
