### **Target Audience**

This program is designed for mental health professionals, psychologists, social workers, marriage and family therapists, counselors, and any other human services professionals interested in this topic.

## **Program Description**

The goal of this day-long training is to introduce and discuss issues related the empirically-based assessment and treatment of individuals, particularly adults, diagnosed with attention-deficit/ hyperactivity disorder (ADHD). ADHD is a disorder with a childhood onset, although many continue to meet diagnostic criteria into adulthood. Given the developmental nature of this disorder, the training will touch on issues related to ADHD across the lifespan.

## **Objectives**

Upon completion of this workshop, participants will be able to:

- Define diagnostic features and clinical characteristics of ADHD;
- Describe the rates of persistence of ADHD into adulthood;
- Describe evidence-based assessment practices of ADHD in adults; and
- Describe evidence-based psychosocial treatment options for adults diagnosed with ADHD.

**John Mitchell, Ph.D.,** is an assistant professor in the Department of Psychiatry and Behavioral Sciences at Duke University Medical Center. His research interests include treatment development for adults diagnosed with ADHD, and ADHD and substance use.
