## Target Audience

Nurses, occupational therapist, physical therapist, nurse practitioner, and other interested health care professionals.

## Program Description

This two day course will prepare individuals to successfully prepare to take the CWCN and CWS/CWSA certification exam. Individuals who are not interested in obtaining certification may also attend the course. The knowledge gained from participation in this two day event will provide participants with valuable insight into the business and science of wound care.

According to the American Nurses Credentialing Center. (ANCC), a board certified nurse can take home around \$9,000 per year more than a non-certified professional. Furthermore, some healthcare organizations are now offering financial incentives and professional development programs to attract and retain certified professionals. By communicating and collaborating with other professionals who are wound care certified, you are able to improve your own knowledge and collectively raise the standards of wound care. In addition, surveys conducted through the ANCC and other professional groups have shown that certification helps wound care professionals to feel better accepted and recognized by physicians and peers.

## Outcome

Upon completion of this knowledge based program, the participant should be able to:

- Describe the anatomy and physiology of the skin and soft tissues;
- Differentiate acute versus chronic wound healing;
- Provide nutritional education to a client;
- Accurately perform and document a wound assessment;
- Differentiate between an arterial versus venous leg ulcer;
- Describe causes of lymphedema in adult patients;
- Identify the etiology of skin burns;
- Determine the stage of a pressure ulcer;
- Describe atypical wounds;
- Determine when debridement is indicated for an infected wound;
- Select a topical treatment for wound management;
- Describe adjunctive wound treatments;
- Differentiate between palliative versus curative wound therapy;
- Identify the level of evidence for wound based literature; and
- Discuss various professional practice issues in wound management.

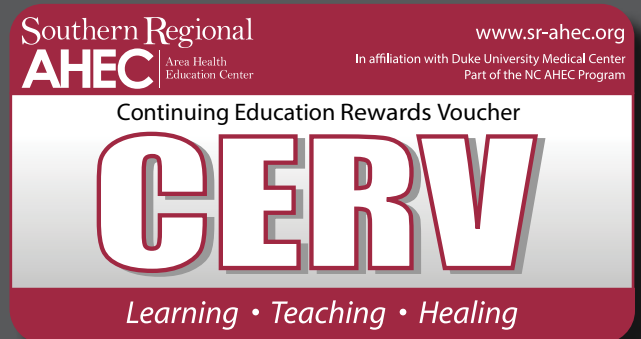
