## Target Audience

Dental Assistant seeking DA II Classification, Dental Hygienists and Dental Assistants seeking review in Medical Emergencies and Infection Control.

## Program Description

This program is designed for dental assistants who want to fulfill medical emergencies and infection control educational requirements set forth by the NC Board of Dental Examiners for DA II classification. This program also targets the entire dental team as it will provide updated information on emergency management and current infection control strategies.

## Objectives

Upon completion of this knowledge based program, the participants will be able to:

- Describe the preventive measures taken for medical emergencies that are commonly occur during dental treatment.
- List qualifications that a dental assistant must have for emergency preparedness
- Describe the common signs and symptoms of an emergency and how to recognize them
- Discuss fundamentals of CPR and AED.
- List basic items that must be included in an emergency kit.
- Discuss the importance of proper documentation of medical emergencies.
- Develop infection control protocol for the dental office.
- Describe infection control measures to be taken to protect the health care worker and patient from the danger of Bloodborne pathogens.
- Recognize NC laws concerning infection control.
- Explain the principles of epidemiology, modes of transmissions and the practice of asepsis.
- Describe protective attire, barrier techniques, engineering and work practice controls to reduce the risk of "sharps" injuries.

## Speaker

**Sheila Lassister, CDA**, possess over 26 years of dental experience, She has served as sterilization technician, clinic coordinator, certified dental assistant and office manager. She has recently "retired" as an instructor for an introductory dental assisting course. As the lead instructor, she has taught and trained students regarding General Chairside, Radiology, OSHA, HIPAA and Medical/Dental Office Emergency.

Sheila also is a dental curriculum provider for SPICE (approved through UNC at Chapel Hill), nitrous oxide for Dental Auxiliary, dental radiology for the Office Trained Dental Assistant (both approved by NC State Dental Board) and Licensed Training Provider through American Red Cross for CPR/First Aid/AED and BBP training for healthcare professionals and lay responders.

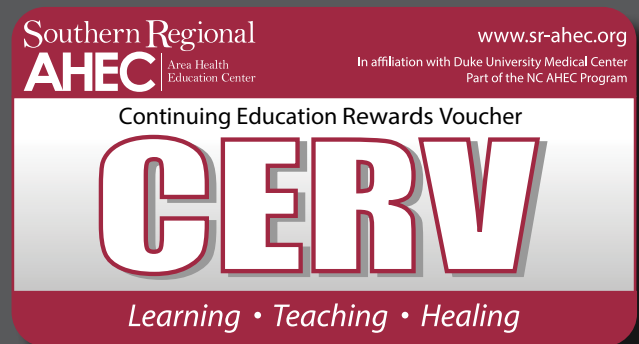
