



# Cognitive Behavioral Therapy with Children & Adolescents: A Blended Learning Curriculum

# **Target Audience**

This course is designed for psychologists, healthcare professionals, clinical social workers, and counselors. Other interested mental health professionals are also invited to attend.

# **Program Description**

Cognitive Behavioral Therapy (CBT) includes a wide variety of empirically-supported interventions for children and families that can be flexibly implemented for a number of presenting mental health and behavioral concerns. Indeed, hundreds of clinical trials have demonstrated the efficacy of CBT-based interventions with children and adolescents, with many of these interventions now considered to have strong empirical support. There are challenges to implementing these interventions across community treatment programs, outpatient clinics, and within private practice. To address this need, we have developed a blended learning curriculum designed to facilitate higher level training in CBT for children and adolescents. Blended learning combines traditional in-person training techniques with ongoing technology. Thus, course participants will receive ongoing training and support from psychologists specializing in child and adolescent CBT. Through the in-person workshops and monthly modules, participants will develop a strong understanding of the core principles of conducting CBT with children, adolescents, and families, as well as gain hands-on practice for how to implement techniques and strategies within their own clinical practice.

# **Program Structure**

This course begins with a 1-day in-person didactic and experiential training. Over the course of the following 6 months, trainees will work with training staff through a dedicated website that provides a range of materials and learning tools for ongoing training. The web-based portion of the course includes monthly webinars designed to review and practice CBT skills. During these webinars, Instructors provide targeted feedback and Trainees have the opportunity to practice skills. Monthly webinar meetings encourage group discussion and consultation regarding clinical challenges implementing CBT principles. In addition, the web-based platform will host peer-consultation and support forums, and will utilize hands-on learning tools for key CBT skills. The training will have another in-person training at the midpoint and then conclude with an additional in-person 6-hour training day where participants will have further opportunities to review principles and hone their skills.

# **Objectives**

Following completion of this program, participants will have improved their ability to:

- Explain fundamental CBT principles
- Discuss complex multi-diagnostic cases using CBT models and case conceptualization
- Describe how to orient children and families to CBT
- Explain functional analysis and its application within case conceptualization and treatment planning with children
- Identify behavioral and cognitive interventions strategies and how to implement these with children and adolescents
- Identify between-session practice targets and measure progress
- Discuss relapse prevention and graduation with families.



**Christian Mauro, Ph.D.**, is an assistant professor in the Department of Psychiatry and Behavioral Sciences at Duke University Medical Center. He is director of the Psychology Internship Program and Psychosocial Treatment Clinic at the Duke Child and Family Study Center, which serves children, adolescents, and families seeking services for a range of psychological difficulties. Dr. Mauro provides direct patient care, teaches through many programs at Duke University Medical Center and supervises and trains clinicians in evidence-based treatment of children and families.
