## Target Audience

Clinicians, case managers, social workers, counselors, psychiatrists, educators, advocates, health and human service practitioners, and any other behavioral health provider.

## Program Description

Trauma Informed approaches have been highlighted to address the varied needs of youth who have experienced trauma through abuse and/or neglect, exposure to violence in neighborhoods, family settings, and other experiences including natural disasters. Research has indicated that unaddressed trauma in youth leads to life-long problems through adulthood. Practitioners must be equipped to treat these problems, such as post-traumatic stress and closely related disorders, behavioral disorders and the interfaces throughout adolescent development.

This training activity will bring together trauma informed practice approaches to treating adolescents who have experienced trauma, along with effective and practical applications for professionals to use in counseling/therapy.

## Objectives

Upon completion of this workshop, participants will be able to:

- Discuss ethics/ethical principles related to assessment/treatment of trauma;
- Explore dynamics of trauma and ethical responses to address mental health and substance use disorders;
- Discuss an overview of trauma informed care principles and ethical considerations for care; and
- Identify and discuss ethical dilemmas consequential to best practice in addressing clients with trauma histories.
