## Target Audience

This training will be beneficial to substance abuse professionals, psychologists, social workers, case managers, counselors, and all other mental health or human service professionals interested in the future of behavioral health electronic health records.

## Program Description

The Division of Medical Assistance (DMA) and The N.C. Department of Health and Human Services Office of Rural Health (ORH) partnered with the N.C. Health Information Exchange Authority (NC HIEA) to launch a program that will assist behavioral health, intellectual development and disability, and mental health practices with purchasing electronic health record (EHR) technology and establishing connectivity to the state-designated health information exchange, NC HealthConnex.

Health care providers that accept Medicaid reimbursement for the provision of health care services must connect to NC HealthConnex, which is housed within the N.C. Department of Information Technology (DIT) pursuant to N.C. Session Law 2017-57. By June 1, 2018, physicians, hospitals and mid-level practitioners that receive Medicaid reimbursement and currently have electronic health record (EHR) technology must connect to NC HealthConnex. All other providers that do not currently have an EHR system and receive funds from the State for the provision of health care services must connect by June 1, 2019.

- Review the functionality of Electronic Health Records;
- Describe what is Safety and Privacy best practices; and
- Summarize the Behavioral Integration Business Model to offset technology cost.

Cancellations less than two business days (Monday-Friday) before the program are non-refundable. Participants who register for a program and do not attend will forfeit the full amount of the program registration fee.

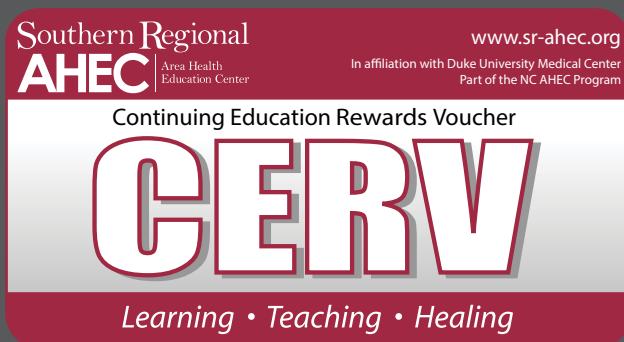
