## Speakers

**Marvin S. Swartz, M.D.**, is a professor and head of the Division of Social and Community Psychiatry, who also serves as director of the Duke AHEC Program and director of the National Resource Center on Psychiatric Advance Directives. Dr. Swartz has been extensively involved in research and policy issues related to the organization and care of mentally ill individuals at the state and national level. He was a network member in the MacArthur Foundation Research Network on Mandated Community Treatment, examining use of legal tools to promote recovery in mental health treatment. He co-led a North Carolina study examining the effectiveness of Psychiatric Advance Directives and the NIMH funded Clinical Anti-psychotics Trials of Intervention Effectiveness study. He is currently a co-investigator of a study of the cost of criminal justice involvement of mentally ill individuals and the effectiveness of gun laws in reducing gun related deaths. Dr. Swartz was the recipient of the 2011 American Public Health Association's Carl Taube Award and the 2012 American Psychiatric Association's Senior Scholar, Health Services Research Award for career contributions to mental health services research.

**Bebe Smith, MSW, LCSW** is project coordinator for the Crisis Navigation Project at Southern Regional AHEC. She worked for 21 years at the University of North Carolina at Chapel Hill in clinical and academic roles. Her work has focused on providing evidence-based treatment and services to persons who live with schizophrenia and other severe mental illnesses. She helped develop the first early psychosis program in North Carolina at UNC in 2005, and was a founder of the UNC Center for Excellence in Community Mental Health in 2008. She also led a pilot of Critical Time Intervention from 2012-2015, an evidence-based intensive case management model for persons with mental illness provided during periods of transition. She was the NASW-NC Social Worker of the Year in 2012.

Directions and Parking Information for **Day Programs**  
(Located on the campus of WakeMed)

Educational activities take place in the **Andrews Center**, between the Wake County Human Services Center and WakeMed.

From I-40 West Wilmington	I-40 West to Raleigh. Take Exit 301 (East and North Raleigh) to I-440 (Raleigh/Beltline). Exit I-440 Beltline at New Bern Ave – Downtown (Exit 13A). <b>The William F. Andrews Center</b> is approximately one-half mile on the left.
<b>From US 64 Rocky Mount</b>	US 64 West to Raleigh. Take the US-440 W exit- EXIT 419- toward US-1 / WAKE FOREST. Merge onto I-440 N. Merge onto NEW BERN AVE via EXIT 13A toward DOWNTOWN. <b>The William F. Andrews Center</b> is approximately one-half mile on the left.
From US 1 North Sanford	US 1 North to I-40 (at Cary). Take I-40 East (Rocky Mount/ Benson). As I-40 East exits to the right toward Benson, stay left and continue to Rocky Mount. Exit I-440 at New Bern Ave – Downtown (Exit 13A). <b>The William F. Andrews Center</b> is approximately one-half mile on the left.
<b>From US 1 South Henderson</b>	US 1 South to I-440 Inner Beltline (Rocky Mount). Exit I-440 at New Bern Ave – Downtown (Exit 13A). <b>The William F. Andrews Center</b> is approximately one-half mile on the left.
<b>From US 70 West New Bern</b>	US 70 West to I-40. Follow I-40 West into Raleigh. (see I-40 West directions)
<b>From US 70 East/85 South Durham</b>	US 70 East to Raleigh. After passing Crabtree Valley Mall, take I-440 North (Wake Forest). Exit I-440 at New Bern Ave - Downtown (Exit 13A). <b>The William F. Andrews Center</b> is approximately one-half mile on the left.
<b>From 1-40 East Greensboro, Chapel Hill, Durham, RDU Airport</b>	I-40 East to Raleigh. Exit I-40 onto Wade Ave (Exit 289). Take I-440/US1 North – Wake Forest exit to I-440 at New Bern Ave - Downtown (Exit 13A). <b>The William F. Andrews Center</b> is approximately one-half mile on your left.

### Parking Directions

Exit I-440 at New Bern Ave - Downtown (Exit 13A).  
Proceed through the traffic light at Sunnybrook Rd. Take 2<sup>nd</sup> left (Emergency Entrance access road). The Andrews Center is on the left. **Note: Parking in P4 is only for patients and those with handicapped placards.**  
Continue past conference center and proceed to stop sign. Turn left and enter **P3 Deck**. After parking, walk back towards New Bern Ave. past the Medical Office Building and continue along the sidewalk to the William F. Andrews Center (last building on right before New Bern Ave). Turn right at the front of the building and follow the sidewalk to the front of the Andrews Center. Enter through the double doors at the Conference Center Entrance.

### If P3 Orange Deck is Full proceed to P1 Visitor

After parking, exit the deck, turn left and take sidewalk to New Bern Avenue. Turn right, walk along the sidewalk toward the Andrews Center, crossing over road between Emergency Room and Andrews. Enter the front entrance of the Andrews Conference Center and proceed to registration.

**Bring your parking ticket to the program and we will validate your parking. If you do not bring the parking pass, you are responsible for parking fees. Parking fees are \$1.00 per hour or a maximum of \$6.00 a day.**
