Physicians, dentists, nurses, pharmacists, behavioral health providers, including psychologists, allied health professionals and all concerned with the health and well-being of adults with I/DD.

Program Description

Innovative programs are improving the health and quality of life for North Carolinians living with intellectual and developmental disabilities (I/DD), yet the majority of adults with I/DD experience significant disparities in health and well-being. The change to an integrative care model has the potential to advance whole person health; however, there is also the risk that the disparities gap will increase. This conference highlights collaborative care initiatives and provides clinical updates that equip providers across disciplines to advance the health and quality of life for adults with I/DD.
