The online scheduling will open to the public **Wed. January 13**, for vaccine clinics at **Cape Fear Valley Medical Center, Hoke Hospital and Bladen County Hospital**. Please go online at **www.capefearvalley.com/covid19** and choose a time block. Time blocks for the Medical Center in Fayetteville will be **7 to 10 a.m., 10 a.m. to 1 p.m., and 1 to 4 p.m., Tuesday through Friday**.

Time blocks for **Hoke and Bladen County Hospitals** will be **10 a.m. to Noon and Noon to 2 p.m., Tuesday - Friday**. As our vaccine supply is limited, space is limited for each block.

At the **Cape Fear Valley Rehabilitation Center Auditorium event**, arrive to the building from the corner of Melrose and John Carlisle Lane and look for the "Event Parking" sign for the designated parking lot.

At **Hoke Hospital**, the vaccine clinic will be located in the Community Conference Room on the second floor, 210 Medical Pavilion Drive, Raeford, off Highway 401. Enter via front entrance and follow the instructions for parking in the main lot.

At **Bladen County Hospital**, the vaccine clinic will be located in the main lobby, located at the front of the hospital, 501 S. Poplar Street, Elizabethtown. Individuals should park in the main parking lot.
